- Appropriate measures must be taken to safeguard minors and ensure their well-being at all times.

4. Compliance with Laws and Regulations

- If a creator is under prosecution or has received a verdict that may harm the reputation of a brand, they must disclose this to the brand before accepting a campaign or project.

 - Any confidential information shared by SWAI or a brand must be handled with care and not disclosed to third parties without explicit consent.

8. Monitoring and Reporting

- SWAI has procedures in place to monitor compliance with this Code of Conduct and platform terms.
- Violations of the Code of Conduct may result in the termination of collaborations or removal from the platform.
